SPECIAL CONDITIONS

- 1. The Grantee shall maintain the dwellinghouse erected on the said land.
- 2. The Grantee shall not erect any buildings until full and proper plans drawings elevations and specifications thereof (including block plans showing the positions of the buildings) shall have been approved in writing by the Local Authority and by the Commissioner of Lands or such other person as may be appointed for the purpose Such plans drawings elevations and specifications shall be submitted in triplicate to the Town Clerk Nairobi.
- Before any buildings may be occupied or used the Grantee shall submit a block plan with the positions of such buildings clearly defined and showing a system of drainage which will satisfy the Commissioner of Lands and the Local Authority and shall also satisfy them that such system of drainage has been properly constructed such satisfaction in both cases to be expressed in writing.
- The Grantee shall suitably connect such drainage system with any town drainage system when in the opinion of the Commissioner of Lands and the Local Authority the latter system is so far completed as to enable the Grantee so to do.
- 5. The buildings shall conform to a building line decided upon by the Local Authority.
- 6. The Grantee shall not erect more than one dwellinghouse (with the necessary offices and out-buildings) without the prior consent in writing of the Governor.
- 7. All out-buildings and offices shall be properly sited and screened from view during the term to the satisfaction of the Local Authority or such other person as may be appointed for the purpose.
- 8. The Grantee shall not erect any building or buildings so as to cover more than one-half of the area of the said land.
- 9. The buildings shall be used for residential purposes only.
- 10. The Grantee shall not assign sublet or otherwise part with the possession of the said land or any part thereof without the prior consent in writing of the Governor.
- for the purpose shall have the right to enter upon the said land and lay and have access to water mains service pipes telegraph or telephone wires and electric mains of all descriptions whether overhead or underground and the Grantee shall not erect any building in such a way as to cover or interfere with any existing routes main or service pipes or the telephone or telegraph wires and electric mains aforementioned.
- or outgoings of whatsoever description as may be imposed charged or assessed by any government or local authority upon the said land or the buildings erected thereon including any contribution or other sum paid by the Governor in lieu thereof.


